

## Submit a Course for CE Marketplace Certification

Please note: If you are a new user and have never used CE Marketplace before you must first submit an application for a School account in order to submit a course for certification.

*The course submission fees are as follows:*

*\$45 - Review within 10 Business Days,  
\$95 - Expedited review within 3-5 Business Days  
\$145 – Expedited review within 1 Business Day*

For existing users: To login to CE Marketplace and your School account, click the 'Login' button in the upper right-hand corner of the home page and use your existing credentials.

Once you have logged in to CE Marketplace you will land on your 'School Management' page. From here you can submit courses for certification, schedule classes once the course has been certified, record class attendance as well as other School administrative functions.

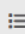

To Submit a course, please make sure you have the following information nearby

- Course Title & Description
- Any Course Supporting Materials that may be helpful to the review process.
- Required Timed Outline Document
- Be able to answer how the course content is pertinent to the real estate industry.

**COMPLIANCE AGREEMENT**

For this course to be certifiable, it must be compliant with statutory requirements and LARA interpretations. Content must be pertinent and specific to real estate. The course must expand the student's knowledge of the real estate profession or stay up with new developments in the industry.

**Elective (General) Topics** - Courses addressing general business issues must be focused on the topic as it pertains to the real estate industry in particular.

**Legal Topics** - For a course to qualify for certification as "Legal" course credit to meet the per licensing year requirement, it must cover law, rules and court cases involving real estate, specific recent enactments or amendments to statutes or rules, or recent court decisions involving real estate law.

**Fair Housing Topics** - For a course to qualify for certification as "Fair Housing" course credit to meet the per licensing year requirement, it must contain content that involves compliance with local, state, or federal fair housing laws.

Course Details include Course Title, Course Topic, Learning Objectives, Course Type, Applicable NAR Designations, upload a copy of your Timed Outline and any optional materials you think would be helpful during the review process, a statement on how the course content relates to the practice of real estate and whether the course should be private or open for other Schools to sponsor.

Following the Course Details, you will enter in the Course Hours which are dependent on your course content. Depending on the content your course may qualify for Elective credit, Legal credit or Fair Housing credit. Please note that each course hour may NOT count toward multiple credit hours.
